Please stop by the Minturn Town Hall on Tuesday, June 7, 2016 between 4:00 PM to 7:00 PM for an informational and input-gathering open house meeting regarding pedestrian/bicycle planning on Minturn's Main Street (HWY 24) from Toledo St. to Maloit Park Road.

Residents of Minturn have repeatedly expressed through committees, master planning, public comments, Planning Commission meetings and Council meetings, the desire for the town to provide a safe mode of transportation for pedestrians/cyclists of all ages, especially along areas of Main Street (HWY 24) where no sidewalk, curb, path or shoulder exists for kids walking to the school bus stop or families trying to get to Little Beach Park (as examples).

The Main Street Pedestrian Planning project is the first action step in the process to meet this public need. Minturn has received a Transportation Alternative Program grant through the Federal Government, to engineer a set of plans for proposed pedestrian and bicycle improvements on Main Street to Maloit Park Road. Minturn then intends to use these engineered plans to apply for grants to assist the funding of constructing such infrastructure. Through a competitive process, the town has hired Stolfus & Associates to be the lead engineer for the project. Stolfus is an engineering firm specializing in transportation projects.

The Minturn Town Council and staff request your feedback at the above scheduled open house. This will be an opportunity to review design ideas, express your pedestrian/bicycle needs as a resident of Minturn, and guide the work being done to improve public safety. You may attend at any time during the three hour period.
