Minturn Municipal Elections

Make a difference in your community and run for Minturn Town Council. Minturn's Municipal Election is coming up on April 2, 2024, and voters will elect a Mayor and four (4) Council members. The Mayor is a two (2) year term, the Council seats consist of one 2-year term and three 4-year terms.

Minturn residents that are interested in running for Mayor or Council may pick up a nomination petition from Town Hall starting Tuesday, January 2, 2024. Once candidates pick up a nomination petition, they have until Monday January 22nd to circulate their nomination petition and file it with the Town Clerk at 302 Pine Street in Minturn. All candidate nomination petitions must be filed by Monday January 22nd to be eligible for the municipal election in April.

Qualifications:

- Citizen of the United States for not less than seven (7) years
- · At least 25 years of age
- Resident of the Town of Minturn for Mayor not less than five (5) years; for Council not less than two (2) years
- A person who has been convicted of a felony shall not be eligible to become a candidate nor serve for an elected Town Office
- · Must maintain residency within the Town of Minturn during the entire term of service

Water Rates

Notice to Residents (Again):

The Town of Minturn completed the 2024 budget approvals on December 6th. Within the budget, it was recommended by the financial analyst to increase the water rates by 12% to cover operating expenses. The Town Council deliberated extensively on this matter and decided to only raise the water rates by 6%, so residents will see a 6% increase in the base and volumetric rates on their water bill beginning 2024.



The full 2024 Town Budget will be posted soon.

Winter Backcountry Safety

Whether you're a beginner or a pro, Colorado's backcountry offers thrilling opportunities to take your skills to new heights and can be tremendously rewarding. However, traveling through Colorado's wide-open snowscape can also be inherently risky.

While there are numerous possible hazards when recreating in Colorado's winter backcountry, avalanches pose the biggest threat and can happen year-round in snowy conditions. The Colorado Avalanche Information Center documented 96 avalanche incidents in 2022–2023 that caught 122 people, an increase from the 10-year median of 56 incidents and 84 people caught.

For those that plan to head into our exhilarating backcountry this winter, <u>Do Colorado Right</u> and keep safety in mind by following the Care for Colorado Leave No Trace Principles. Minimize your risk by planning ahead — <u>check the avalanche forecast</u>, carry avalanche-rescue gear, be prepared for changing conditions and recreate responsibly.

Help us share these important resources to educate visitors on how to safely enjoy Colorado's amazing back-country and <u>Care for Colorado</u> in 2024 and beyond.



Railroad Ave Safety Improvements Grant Award

Governor Polis Announced Minturn as a grant recipient for the Revitalizing main Streets grant award in the amount of \$250,000 which will go toward improving safe access from north Minturn to Main Street via Railroad Ave. This will include the creation of a sidewalk, stop signs, bulb out and traffic calming. Planning Department Update

The Minturn North Planned Unit Development (PUD) consisting of 39 lots, and its associated Final Plats and Subdivision Improvements Agreement was approved on November 15, 2023 via Ordinance 15 – 2023, Ordinance 16 – 2023, Ordinance 17 – 2023, and Resolution 31 – 2023. The Minturn North PUD has been planned and designed as a strictly residential neighborhood with lots, streets, sidewalks, trails, pathways, and various open spaces designed to closely complement and respect the scale and development pattern of the existing Taylor Avenue neighborhood as well as other established neighborhoods in Minturn. Seasonal Trail Closures

The Town of Minturn would like to remind our residents and visitors, that the Mini Mile trail, and the Minturn Bike Park, are closed for the winter season. This is a wildlife closure that the Town hopes everyone will respect to allow for wintering habitat for the elk.

In addition, to help respect and protect wintering wildlife, we kindly ask that dogs are kept on leash in the Little Beach Park and surrounding areas. That entire area is an elk migration / winter range corridor and disruption can lead to extremely harmful outcomes for wintering wildlife.

Mountain Community Survey

CAST (Colorado Association of Ski Towns) is again partnering with the Northwest Colorado Council of Governments on a research effort. The Mountain Community Survey is designed to capture the diverse experiences and perspectives of those connected to our western mountain regions as our communities look to balance tourism and resident interests. The target audience for the survey is local residents, second homeowners, and the workforce who commute into your communities. Your input will help shape the future of our mountain communities.

Survey Distribution:

In early December, postcards were sent to a random sample of residents and second homeowners across the five NWCCOG counties. This approach was designed to obtain a statistically valid data set from a broad and representative sample.
